

Grouting materials



APPLICATION:

Amorphous silica is a white, high-purity powder that is used as an admixture to GE epoxy grouting materials to increase their density and thixotropy. This product can be used for the grouting of wide joints (greater than 10 mm) - there is a risk of settlement or leakage of grouting materials.

Characteristic features:

- thickening
- adjustment of thixotropy
- odourless
- chemically resistant
- hygienically safe, without effects on the environment

COMPOSITION:

Unmodified, hydrophilic amorphous pyrogenic silicon dioxide.

TECHNICAL PARAMETERS:

PROCESSING:

After mixing, amorphous silica is added to epoxy grouting materials, namely 0.1-0.5% of the volume of prepared materials (i.e. 1-5 g/kg - in weight, or 20-100 ml/kg of materials - in volume) The amount depends on density of grouting materials.

CAUTION:

- Unused residues should be disposed as of other wastes (see the Safety Data Sheet).
- Only completely clean plastic materials may be handed over to recycling.

SAFETY AND HYGIENE REGULATIONS:

This product is not classified as a dangerous substance.
