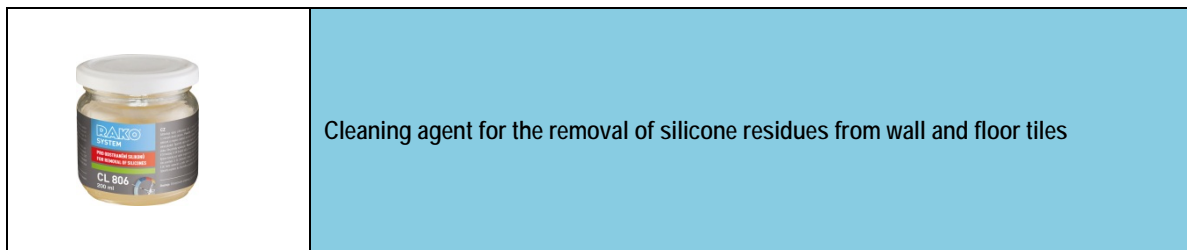


CL 806

Cleaning agents



APPLICATION:

This is a special product intended for the removal of residues of silicone jointing materials. The product must be applied undiluted in the delivered gel-like consistency.

COMPOSITION: Non-ionic surfactants, ethoxylated alcohols, and methadiene.

TECHNICAL PARAMETERS:

Ph value	4-7
Physical form at 20°C	liquid
Approximate coverage:	approx. 20 ml of this product for 1 running metre of joint

PROCESSING:

Using a brush, apply the undiluted product into a joint to be cleaned, and leave it to act for a longer time. Then, using a plastic spatula, scrape the swollen silicone residues from the surface – perform this activity with sufficient pressure.

After mechanical cleaning, remove any residues from the joint by washing with water.

While handling the cleaning agent, the use of protective working equipment is recommended.

CAUTION:

- Before using this product, please read the instructions for use carefully, and follow the manufacturer's instructions.
- High temperatures with thermal decomposition may lead to the formation of toxic products.
- Unused residues and contaminated containers should be disposed as of hazardous wastes (see the Safety Data Sheet).

FIRST AID:

In the event of health problems, or if in doubt, contact your doctor. If unconscious, place the victim in the recovery, side position with the head slightly tilted back and establish a clear airway. Never induce vomiting. If the victim vomits, take care to prevent aspiration of vomit. Remove the victim to fresh air and secure physical and mental rest. Do not let the victim get cold. If irritation persists, seek medical advice. May cause sensitization by skin contact. Take off immediately all contaminated clothing. Wash exposed parts of skin preferably with warm water and soap, or use a suitable cleaning agent. Never use thinners or solvents! If irritation persists, seek medical advice. After eye contact, rinse with clean water for at least 15 minutes, possibly with forcibly opened eye lids, and seek medical advice. If swallowed, keep the victim at rest. Rinse mouth with water (only if the victim is conscious); never induce vomiting. Do not drink water. Seek medical advice immediately and show the product container or label.
