PE dilatation and separation self-adhesive tape

APPLICATION:

A single-sided adhesive foam tape, suitable for the creation of mechanical and sound dilation along the circumference of floor structures good adhesion to many bases, such as plastic materials, including polycarbonate, wood, metal, and glass.

For the separation of applied layers of materials in LBCS system solutions.

It reliably interrupts the sound bridge, and avoids undesirable contacts of structures.

The tape is silicone-free, therefore, it can be used it in facilities that require its application, such as paint shops, etc.

This product is ideal for contact with silicone sealants if adhesion of sealant is not required, for example, to define the bottom of a joint.

Advantages:

- rapid, easy and smart application;
- good resistance to ageing.

Separation foam material, free of softeners on the basis of PE, with a closed cell structure, provided with a rubber adhesive on one side and a PP layer on the other side.

BASE PREPARATION:

The bases must be dry, degreased, free of dust, dirt, and loose particles. Absorbent bases should be penetrated using PE 202.

PROCESSING:

Uncoil the tape from a roll, measure, and cut-to-length as needed. Then, apply the product directly on the prepared base surface. Press the tape firmly to the base. If the material with a cover foil is used, the protective strip must be removed before application.
