

A cord for the separation of flexible sealants from the base, especially in LBCS system solutions.

To define a suitable shape of cross-section of flexible sealants.

The cord is silicone-free, therefore, it can be used in facilities that require its application (such as paint shops, etc.).

This product is ideal for contact with silicone sealants if adhesion of sealant is not required.

# PROCESSING:

The cord diameter is to be selected proportionally bigger than the width of the sealed joint. Unroll the cord, measure the necessary length, and cut the cord. Then, insert the cord directly into the prepared joint. Seat the cord in position to create a suitable space for application of a given type of flexible sealant. Then, sealing can be performed immediately.

### CAUTION:

- Unused residues should be disposed as of other wastes (see the Safety Data Sheet).
- Only completely clean plastic materials may be handed over to recycling.

#### SAFETY AND HYGIENE REGULATIONS:

This product is not classified as a dangerous substance.

#### STORAGE:

If stored in a dry place, at least 24 months. The expiration date is specified on the packaging.

#### SHIPPING:

A bundle in a length of 100 m.
