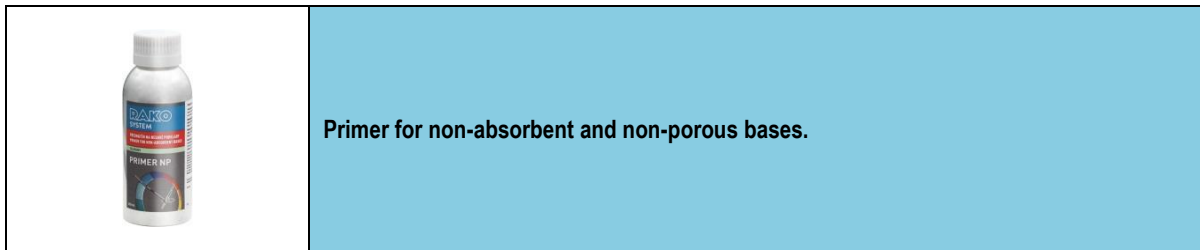


PRIMER NP

Primer



APPLICATION:

This product is intended for the improvement of adhesion of silicone sealants **SI** and **NSI** on non-absorbent (non-porous) surfaces, such as ceramic tiles, hardened plastics, and metals. Transparent, low viscous coating – does not create a film. On the basis of the fact that individual base surfaces are often different in real-life working, it is necessary to understand these recommendations for the use of primer as a suggestion for adhesion tests. In any case, adhesion tests should be carried out at all important or large facilities.

COMPOSITION:

Acrylate – silicone – copolymer.

TECHNICAL PARAMETERS:

Aeration time (at 23 °C and 50 % air relative humidity)	30 minutes
Application of silicone sealant	from 30 minutes to 2 hours
Approximate coverage – depending on the type and suction capacity of base*)	Approx. 7-15 ml/current metre

*) It is recommended to determine the exact coverage on a test surface.

BASE PREPARATION:

The base must be dry, firm, free of dust, free of released particles, and free of film-forming agents with the effect of separation, such as release lube.

PROCESSING:

The product is applied using a brush, or cloth, to contact surfaces (sides of joints). Use a self-adhesive cover tape to achieve clean edges of joints. Immediately after the application, close the container tightly. Keep the product dry. Aeration time – 30 minutes (at an ambient temperature of 23°C and 50% relative humidity). The silicone sealant is to be applied in the time range of 30 minutes to 2 hours.

CAUTION:

- Keep away from flame sources – do not smoke during application.
- Wear suitable protective equipment while handling the product.
- Do not empty into drains.
- Methods of product disposal – collect the residues mechanically and let them soak into suitable absorbent materials (sand, sawdust, VAPEX, vermiculite, etc.). They should be disposed as of hazardous wastes together with contaminated containers (see the Safety Data Sheet).

FIRST AID: In the event of health problems, or if in doubt, contact your doctor. If inhaled, remove the victim to fresh air, ensure rest, and prevent underheating. In contact with skin, remove immediately contaminated clothing. Wash affected skin with water and soap. Apply an appropriate cream to irritated places. After eye contact, rinse with clean water for at least 15 minutes, possibly with forcibly opened eye lids, and seek medical advice. If swallowed, rinse mouth with water and let drink about 1/2 litre of clean water. If problems persist seek medical advice. If the symptoms of any affection (irritation) caused by contact with the product do not subside after providing first aid, seek medical advice.
